PROPOSAL NARRATIVE

BACKGROUND

<u>History and Accomplishments</u>: St. Vincent's is Santa Barbara's longest, continuously-operating nonprofit human service agency. For 156 years, St. Vincent's has been providing support, education, and shelter, with compassion and caring, to low-income families in Santa Barbara without regard to race, ethnicity, gender, or religious beliefs.

In 1858, St. Vincent's opened the first English-speaking school and orphanage in Santa Barbara, and the first infirmary in the region in 1873. Responding to the needs of working parents in 1917 during WWI, St. Vincent's began one of the first childcare programs in California. Eventually, the orphanage gave way to the pressing need for residential, educational services for developmentally disabled children. St. Vincent's opened and operated the first such program in the western United States from 1936 to 1995.

<u>Current Programs and Activities:</u> Today St. Vincent's educates, houses, and cares for over 600 low-income and at-risk children, mothers, families, and seniors on its 21-acre campus in the heart of Santa Barbara:

- St. Vincent's Family Strengthening Program offers shared transitional housing and extensive services for at-risk single and/or pregnant mothers with young children, helping them to move towards stability and independence.
- St. Vincent's Early Childhood Education Center provides quality childcare and affordable education for 56 infants, toddlers, and preschoolers on campus and in the local Santa Barbara community, with a wait list of over 70 children.
- St. Vincent's Heart is an on-site, volunteer-assisted food pantry and donation center providing basic necessities for clients and residents. Food is purchased weekly from the Foodbank of Santa Barbara County, and distributed along with clothing and other household items.
- St. Vincent's Affordable Housing is the single largest affordable housing development in the history of Santa Barbara County. St. Vincent's Gardens provides 75 apartments for low-income families, and Villa Caridad provides 95 one-bedroom units for low-income seniors 62 or older.

Relationships With Other Organizations Working to Meet the Same Need: St. Vincent's receives referrals from local clinics, hospitals, churches, women's and homeless shelters, and domestic and child abuse resource centers, as well as CALM, Child Welfare Services, CalWORKs, the Santa Barbara Council on Alcoholism and Drug Abuse, and the California Department of Rehabilitation. St. Vincent's successful creation of a large, multi-cultural and inter-generational community where low-income and at-risk individuals and families are cared for physically, emotionally, and spiritually is completely unique, and promises lasting change in the lives of those whom St. Vincent's serves.

FUNDING REQUEST

The Need or Problem Our Project Works To Address

Villa Caridad is the affordable housing for seniors 62 or older on St. Vincent's campus. The building, which was opened in 2007, has 95 one-bedroom apartments. In the summer months, and frequently throughout the year, our senior residents suffer from heat-related illnesses due to the lack of cross ventilation or air conditioning in the units. This is especially true for those seniors who are homebound, and unable to easily leave the building to seek cooler temperatures. We are requesting funding from the St. Francis Foundation to install ceiling fans in each of the units to help alleviate this problem.

Our Project's Goals and Specific Outcomes Projected for the Grant Period

Goal: Installation of ceiling fans in all Villa Caridad senior apartments

Outcomes:

- 1) Reduced number of Villa Caridad senior residents becoming overheated in their apartments
- 2) Reduced incidence of heat-related illnesses among Villa Caridad senior residents
- 3) Increased level of comfort for Villa Caridad senior residents
- 4) Enhanced quality of life for Villa Caridad senior residents

Description of Our Project

New, Ongoing, or Expansion: The installation of ceiling fans in the Villa Caridad senior apartments is a new project for the affordable housing program at St. Vincent's. As of January 1, 2014, St. Vincent's assumed the managerial responsibilities of Villa Caridad, which was previously managed by Mercy Housing. As such, St. Vincent's is now in the position to make needed improvements to the property. The installation of ceiling fans for the seniors is one of St. Vincent's top priorities, as it directly impacts the health of our residents.

According to the California Department of Health, seniors can get heat illness more easily than younger people. Their bodies do not adjust as well to sudden changes in temperature. They are also more likely to have a condition that upsets the body's normal response to heat. Further, they are more likely to take medications that make it harder for the body to control its temperature and to sweat. The National Institute on Aging states that heat-related illnesses can become serious if preventative steps are not taken. Many people die of heat stroke each year; most are over 50 years of age. Lifestyle factors that can increase risk include people who live in homes without fans or air conditioners, as well as a lack of transportation. People without fans or air conditioners often are unable to go to shopping malls, movie houses, and libraries to escape the heat because of age, illness, and/or the lack of transportation.

Target Audience: The 105 seniors who currently reside at Villa Caridad on St. Vincent's campus.

Activities/Strategies That Will Be Used To Meet Our Stated Outcomes:

- 1) Raise the senior residents' awareness of how to stay healthy during hot weather, and recognize the warning signs of heat stroke and heat exhaustion.
- 2) Educate the senior residents on the importance of, and use of the ceiling fans during the hot summer months.
- 3) Maintain and inspect the ceiling fans on a regular basis.

General Timeline: The installation of the ceiling fans at Villa Caridad is estimated by St. Vincent's Director of Maintenance, Antonio Frausto, to take approximately five weeks to complete, averaging four fans to be installed per day. While we are dependent upon funding to initiate this project, ideally we would like to have the work completed before July of this year, and the hottest weeks of the summer.

Plan to Evaluate the Effectiveness or Impact of the Project

St. Vincent's will conduct a survey of the senior residents at Villa Caridad after the ceiling fans are installed. We will evaluate their effectiveness in reducing the seniors' heat-related illnesses and increasing their overall comfort level during the hot summer months.

Skills and Relevant Experience of Key Staff Essential to the Project's Success

Antonio Frausto, Director of Maintenance, St. Vincent's

This project will be led by Antonio Frausto, St. Vincent's Director of Maintenance. Antonio received his Associate of Science degree in Construction Technology from Santa Barbara City College in 2012. He began working at St. Vincent's in 2009, and became the Director of Maintenance in 2013. His job duties include developing and maintaining a preventive maintenance program on St. Vincent's 21-acre campus, communicating and preparing work schedules for St. Vincent's five-person maintenance crew, and performing work orders including but not limited to plumbing, electrical, drywall, cable, set up and clean up, landscape, irrigation, and inspections.
