Outreach to community organizations that work directly with the homeless, veteran, and Latino populations to expand our impact. Since the beginning of the fiscal year, we delivered presentations to the following nine organizations, most of whom work closely with the above referenced populations: Casa Esperanza, Santa Barbara Neighborhood Clinics (physicians), California Children's Services (for transitional aged youth), Adult and Aging Network, Hotel de Riviera, Restorative Courts, Doctors without Walls, State of California Department of Rehabilitation (local office) and the Faulding Hotel. We additionally provided tours of the Jodi House facility for staff from Santa Barbara City Housing Authority, Sanctuary Psychiatric Centers, County Health Care Services, and the Hosford Clinic from UCSB; and participated at health fairs at several community venues. As a consequence of this outreach, we are serving more homeless individuals with brain injuries, and have been able to provide them with additional case management and social-emotional support through our day program to help move them towards selfsufficiency.

Administer Quality of Life after Brain Injury Questionnaire (QOLIBRI) to each member and the Mayo Portland Adaptability Inventory to caregivers twice per year and collect survey results for future curriculum planning. We administered the QOLIBRI to 29 members on two separate occasions over the past fiscal year... Results showed that 90% of members surveyed reported overall improvement in their quality of life, 6-9 months after enrolling in Jodi House's program, with the greatest

improvements in physical, emotional, and cognitive function, as well as their views of themselves. Members reported lower improvements in social and independent functioning. We are addressing these areas in our new program model, in which we have added a specific case management component, as well as independent living skills classes. Our half-time social work intern is working with members to provide them with support and guidance regarding their interpersonal relationships, and referral to additional appropriate community resources. We have added weekly independent living skills classes to our day program calendar, including budget planning, social skills, and healthy cooking, to support our members in moving towards successful community integration. We have not been able to get enough Mayo Portland follow-up surveys completed on caregivers to make any generalizations about their results, due to some difficulty in reaching the caregivers.

Have at least 6 graduates from the Immersion Services Program by the end of its first year. We ended up with 5 program graduates as of summer, 2014. This program, a contract and collaboration between Jodi House and the State of California, Department of Rehabilitation (DOR), is the first of its kind in the state, and Jodi House is proud to be a leader in supporting brain injury survivors to successfully returning to the workforce. Referrals from the DOR have been slower for this program than we anticipated however given our small staff size, we are happy to be able to provide individualized attention to those who have participated. Of the program graduates, two have obtained permanent jobs, one is working various temporary positions, and two are involved with regular volunteer work. We currently have two additional participants in the program at the present time, one of whom will be graduating within the next month or so. We plan to continue to actively providing outreach to community organizations regarding this program, in the hopes of growing program numbers over time.

We cannot thank the St. Francis Foundation enough for your support of our programs in this past year, and thank you so much for your consideration regarding this request.

Organization Background

History and Accomplishments

Jodi Wustman was hit by a drunk driver in 1982 when she was 19 years old. After her family was unable to find suitable resources for adult brain injury survivors in Santa Barbara County, they got together with families of other brain injury and stroke survivors to start a weekly support group. As the group continued to grow, they began adding more programs and in 1994, Jodi House gained a physical location in Santa Barbara. In 2010, we moved to our current location in the heart of downtown Santa Barbara. Since then, we have continued to expand our services to provide a greater variety of activities, support groups and outreach to the community. In 2006, we opened a weekly program in Buellton in order to increase our impact in the county. In the past 33 years, Jodi House has developed as a model resource for survivors of traumatic brain injury (TBI), stroke, aneurysm and tumor. In 2013, we expanded our services through the establishment of a contract with the California Department of Rehabilitation (DOR). Jodi House is the only organization statewide offering a pre-vocational program (in conjunction with the DOR) for brain injury survivors wishing to re-enter the workforce, and is the only non-profit organization countywide exclusively providing services to adults with brain injuries. We are currently providing services to 132 active members.

Programs, Activities and Constituency

Jodi House's day program is a supportive, community-based program, consisting of structured activities that facilitate community reintegration. Groups that promote social and emotional support, activities that enhance speech and communication skills, and movement and nutrition classes are offered at both the Santa Barbara and Buellton locations. Participants of our pre-vocational program work through independent assignments, one-on-one assistance, and community outings to complete the ten competencies which teach them the skills needed to gain meaningful employment or volunteer work. Our Resource & Referral Program serves family members and caregivers of Jodi House members, and the community at-large to provide information and support regarding acquired brain injury and TBI, and referrals to various agencies that provide mental wellness, continued medical care and rehabilitation, vocational resources, social services and education programs.

Jodi House members range from 20-90 years old, with an average age of 55. 51% of members survived a traumatic brain injury, 38% are stroke survivors, and the other 11% are survivors of aneurysm, tumor, or hydrocephalus. Two thirds of our members are unemployed, and three quarters earn less than \$20,000 in income (most rely solely on SSI or SSDI).

Organization Relationships

Jodi House formally collaborates with the California Department of Rehabilitation through our prevocational program. In addition, we have close relationships with a variety of organizations in the community including, but not limited to Casa Esperanza, Coast Caregiver Resource Center, Independent Living Resource Center, Santa Barbara Street Medicine, Solutions, and Cottage Rehabilitation Hospital. We frequently refer our members to their services and are referred members in return. These relationships allow us to best serve brain injury survivors in our area.

Funding Request

Problem our Project Addresses

In the United States, approximately 1.7 million people experience a traumatic brain injury and 800,000 experience a stroke every year. Jodi House completes the spectrum of care that begins when a stroke or traumatic brain injury survivor enters Cottage, Marian, or Lompoc Hospital for emergency critical care. They then move to Cottage Rehabilitation Hospital, whom we work closely with, and lastly to Jodi House where we ensure that survivors are able to successfully adapt back into their communities. Jodi House is the only non-profit organization in Santa Barbara County exclusively providing services to adults with brain injuries.

By providing a supportive environment with staff that is trained to work with brain injury survivors, we are ensuring that these survivors learn to live with their disability and continue to hold their health as a personal priority. By supporting, educating and assisting brain injury survivors, Jodi House is not only improving the quality of life of each survivor but also improving our community by preventing these survivors from experiencing a variety of negative outcomes that frequently follow brain injuries.

Goals and Outcomes

We are requesting funding for our enhanced Brain Injury Support program, to focus on two specific populations:

- Recent brain injury survivors who have just been discharged from acute care and/or inpatient rehabilitation, and
- Homeless adults with brain injuries (either injured recently or longer ago) in need of support in securing housing and employment.

Our three performance targets are as follows:

- 40 individuals will participate in our Brain Injury Support program; of these, 25 will "graduate" from the program, successfully achieving the goals set at intake.
- 10 members will enroll in the Vocational Supported Services portion of our Brain Injury Support program; of those, 5 will graduate and obtain paid employment or volunteer work within 12 months. We will do follow up calls with graduates to determine their employment status 6 and 12 months after they complete the VSS program.
- 10 homeless individuals will participate in our new program; of these, 5 will secure housing as a result of the counseling, advocacy, and case management they received at Jodi House.

Project Description

The purpose of our expanded Brain Injury Support program is to support the post-discharge recovery of brain injury survivors. Jodi House is the only non-profit organization in Santa Barbara County exclusively providing services to adults with acquired and traumatic brain injuries. There are an estimated 25,000 individuals in our county either living with, or caring for someone with a brain injury. This equates to roughly six percent of the county population affected by brain injury. Survivors are at an increased risk of suicide, major depressive disorder and substance abuse and are 400 times more likely to become homeless than a person who has not experienced a brain injury. Our programs work to decrease the number of survivors that experience these problems; completing the spectrum of care that begins when they enter Cottage, Marian, or Lompoc Hospital for critical care. Subsequently they receive inpatient rehabilitation, and lastly come to Jodi House where we ensure that they are able

to successfully adapt back into their communities. Additionally, we are now actively working with the homeless population to identify those that have brain injuries. We will be providing intensive case management that would otherwise be not available to these individuals to address their needs based upon the brain injuries as well as to support them in finding housing and employment.

Our program is evidence-based and research-supported. It is comprised of: Community Integration with support groups, independent living skills, and physical and cognitive rehabilitation classes; Supported Living Services, where staff develop an individual service plan with each brain injured survivor and schedule home visits to assess home safety issues; and Vocational Supported Services (VSS), where participants work through a curriculum to gain the skills needed to obtain employment or volunteer positions. We have a social work (MSW) intern working 20 hours weekly providing individual case management, under the supervision of a Licensed Clinical Social Worker. Ideally in a year or less members move through our program and "graduate" after successfully meeting the goals set at intake. The goal with all members is community reintegration, returning to functioning at their highest possible level with jobs, for those who are able to work, and stable housing. Our program is available on an ongoing and long-term basis for those with more severe brain injuries, for whom graduation is not feasible.

An additional component of our enhanced program is our staff having regular hours at Casa Esperanza and other local homeless shelters to identify homeless individuals with brain injuries. We wish to focus on providing services to this population so that they are able to receive specialized support for their injuries, and more intensive case management to assist them in securing housing and employment. Even though the incidence of brain injuries is substantially higher among the homeless population, these individuals are currently not receiving any specialized support. We are in the formative stages of partnering with Santa Barbara City Housing Authority in order to help their staff identify and provide services to their residents to support them in maintaining housing.

Most Pressing Needs

Our most pressing needs revolve around the day-to-day function of Jodi House. Staff is our most precious resource, with only three full time employees and one part time staff member, we try to provide as much individualized attention as possible, while utilizing volunteers and interns for support. In addition, we are always in need of everyday supplies such as paper towels, toilet paper, soap, etc. which are necessary for Jodi House to continue to be open to our members and their loved ones.

Evaluation of Impact

We evaluate our program using the Quality of Life After Brain Injury Scale (QOLIBRI). Most recent evaluation results for our members 9-12 months after enrolling at Jodi House showed improvement in all categories, with the greatest improvements shown in Emotional Functioning, Physical Problems, View of Self, and Cognitive Function. We also track the number of graduates obtaining housing and employment 6 and 12 months post-program completion, as well as the number of members graduating from our program after meeting the goals set at intake.

Survivors regularly evaluate each class that we offer and our staff uses those results to introduce new classes and continue those that have the most impact. Additionally, once monthly we hold an open session with our Executive Director where members are free to provide suggestions and concerns regarding the program. Finally, many of the survivors that attend Jodi House offer hours of volunteer

work when they are physically and cognitively able. They assist in easing the transition with new members into the day program, with grounds maintenance, caring for the fish, and outreach presentations in the community.

Staff Skills and Experience

Our Executive Director, Eryn Eckert, has worked at Jodi House for just under two years. She has worked in non-profit administration for 11 years, and with cognitively impaired adults for 15 years and has a doctoral degree in research psychology. Other staff bring experience in psychology, healthcare, and teaching. Program contractors and volunteers include licensed speech and occupational therapists, a functional neurologist, an MFT art therapist, and trained yoga instructors. Our supportive Board of Directors includes the Director of Trauma at Cottage Hospital, an experienced clinical Psychologist, DPH candidate, and many fundraising and finance professionals. Our relationships with high schools and universities in the area have formed a strong volunteer and internship base for the organization. We are grateful for the many bright students that volunteer from Westmont College, UC Santa Barbara, Santa Barbara City College, and local high schools. Finally, an increasing number of community leaders and health care professionals are supporting Jodi House's mission and programs. Our Professional Advisory Board includes some of Santa Barbara's top neurologists, neurosurgeons, trauma surgeons and nursing and rehabilitation professionals. The combination of these backgrounds and skills provides Jodi House with the skills necessary to successfully implement and maintain vital resources and services to those affected by brain injury.

Contingency Plan

In addition to the St. Francis Foundation, Jodi House is seeking funding from the Hutton Parker Foundation, the Williams-Corbett Foundation, and the Towbes Foundation. Additionally, Jodi House will be applying to become one of the state's seven sites that receive funding for providing services to adults with traumatic brain injuries through the California Department of Rehabilitation. Our development team continues to work on an ongoing basis to cultivate new donors and move annual donors to the major donor level.

Member Spotlight

After suffering a stroke in October of 2013, David was left without a place to live or support in his recovery. He found temporary shelter at Casa Esperanza in July of 2014 and was referred to Jodi House shortly after. With the support of Jodi House staff and fellow members, David focused on his recovery and began to truly understand what had happened to him as a result of his brain injury. On top of being a stroke survivor, David also suffered from diabetes. Jodi House staff taught David how to manage his diabetes through appropriate food choices and beneficial exercise techniques. After a few months at Jodi House, David found himself homeless again. He was unable to properly care for himself, and Jodi House staff became concerned that he may not survive much longer if left out on the street. They reached out to his only remaining relative, his grandmother, who lived in Florida. After reassurance from the staff that David was focused on recovery and could benefit from time spent with family, she agreed to have him come live with her in January of this year. Since that time, Jodi House staff has made regular follow up calls to track his progress. According to both of David and his grandmother, everything has been going well. Without Jodi House's involvement, he might not be where he is today.
